### <u>The Rise of European Right-Wing Populism and Its Implications</u> for LGBTQ+ Rights: A Comparative Analysis of Poland Versus <u>Sweden's Attitudes toward Queer Communities</u>



This paper examines the factors causing some European Union (EU) member states to enforce queer rights while others do not, drawing on Sweden and Poland as countries on opposite ends of the LGBTQ+ norm pioneer spectrum. It finds Poland's corrosion of public trust through the Law and Justice party contrasts with Sweden, a country built on a foundation of social trust in democratic practices. The paper concludes that the EU must take action to enforce LGBTQ+ rights by earmarking a sector of its funds to uplift LGBTQ+ NGOs and conduct dialogue with member states like Poland that harbour oppressive policies.
